The Vermont Chapter is pleased to announce this seminar on an important aspect of effective Arson Investigations presented by Detective Barry M. Grimm, Middletown Twp Police Dept., NJ. Mr. Grimm serves as a forensic identification specialist and arson investigator. Detective Grimm provides technical, photographic, and laboratory assistance in many police cases and fire investigations, including fires of both accidental and incendiary origin. Since 1985 Det. Grimm has been an Adjunct Instructor at the National Fire Academy in Emmitsburg, MD. He teaches most of the arson related programs there. He is a lead instructor for the NJ Div. of Criminal Justice Arson program, which is a 90 hour course that certifies New Jersey's Fire/Arson investigators. Together with Fire Chief Ronald M. Churchill, Det. Grimm's heaviest areas of concentration are the fields of Fire, Arson, and Interview and Interrogation. They have taught around the country(30+ states). He is working with the Bureau of ATEE re-writing the NFA Fire Arson Investigation Course.
